1. NAME OF THE SOCIETY : "ALUMNI ASSOCIATION OF VAAGDEVI COLLEGE OF ENGINEERING" BOLLIKUNTA (V)
2. LOCATION OF THE OFFICE : VAAGDEVI COLLEGE OF ENGINEERING, BOLLIKUNTA (V), WARANGAL DISTRICT.
3. (i) MEMBERSHIP : Age above 18 years person.
(ii) CATEGORY OF MEMBERS :
 - 1) Student Member
 - 2) Ordinary Member
 - 3) Life Member
 - 4) Honorary Member
 - 5) Erstwhile Members of All India Alumni Association.
- (iii) ADMISSION FEE AND THE ANNUAL SUBSCRIPTION OR MONTHLY SUBSCRIPTION. :
Rs.200/-
Rs.600/- per Annum.
4. GENERAL BODY:
 - (i) Annual General Body will meet once in a year i.e., in the month of MAY
 - (ii) FUNCTIONS:
 - a. To Pass the budget for the ensuring year and approve the expenditure statement of previous year.
 - b. To approve the reports of the activities of the society.
 - c. To elect the Executive Committee etc.
 - d. To appoint Auditor.
- 5.(i) Executive Committee: Shall consist of seven (7) members and out of them, the following office bearers shall be elected by the E.C. Viz. President, Vice-President, General Secretary, Joint Secretary, Treasurer and the remaining persons are the members of the Executive Committee.
(ii) The members of the Executive Committee (Governing Body) shall be duty bound to attest the signatures of all the members of newly elected Executive Committee and to see that the signatures of the out going Governing Body tally with the annual list as filed with the Registrar of Societies before 15 days of the succeeding month in which elections were held.

SIGNATURE OF THE PRESIDENT/SECRETARY

(III) FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS :

1. **PRESIDENT :**
He preside over all the meetings of the General Body and Executive Committee. He can cast his vote in case a tie in decision making. He can supervise all branchers of the society.
2. **VICE - PRESIDENT :**
He shall assist the President in discharging his functions. In the absence of the president he will perform the duty of the president as entrusted by the president.
3. **SECRETARY :**
He is the Chief Executive Officer of the Society and Custodian of all records relating to the society and correspondent on behalf of the Society. He has to take or record all minutes of the society, would convene both the Executive Committee and General Body of the Society with the permission of the President. He guides the Treasurer in preparing the budget and expenditure statement to place before the General Body for its approval.
4. **JOINT SECRETARY :**
He has to do the work entrusted by Executive Committee. He has to assist the Secretary in discharging his duties. In the absence of the Secretary, he can perform the duties of the Secretary.
5. **TREASURER :**
He is responsible for all financial transactions and Funds of the Society / Association. He has to maintain accounts properly along with the vouchers. He has to prepare the accounts of the society jointly with the secretary or president.
6. **OFFICE BEARERS :**
They are responsible persons to attend to such activities of the Society / Association which the Executive Committee entrusts to them.
7. **QUORUM :**
Half of the total members for General Body Meeting and 1/4 for Executive Committee Meeting.
8. **FUNDS :**
The funds shall be spent only for the attainment of the objects of the society and no portion there of shall be paid or transferred of indirectly to any the members through any means.
9. **AMENDMENTS :**
No amendment or alteration shall be made in the purpose of society/Association unless it is voted by 2/3 of its members present at a special meeting Convened to the purpose and confirmed by 2/3 of the members present and at a second special meeting.
10. **WINDING UP :**
In case the Society has to be wound up the property and funds of the Society / Association that remain after discharging the liabilities, if any, shall be transferred or paid to some other institute with similar aims and objects.

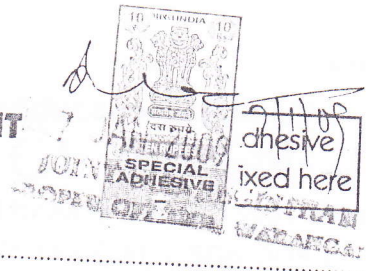

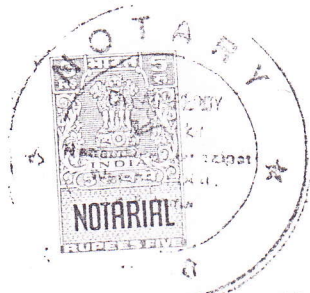
